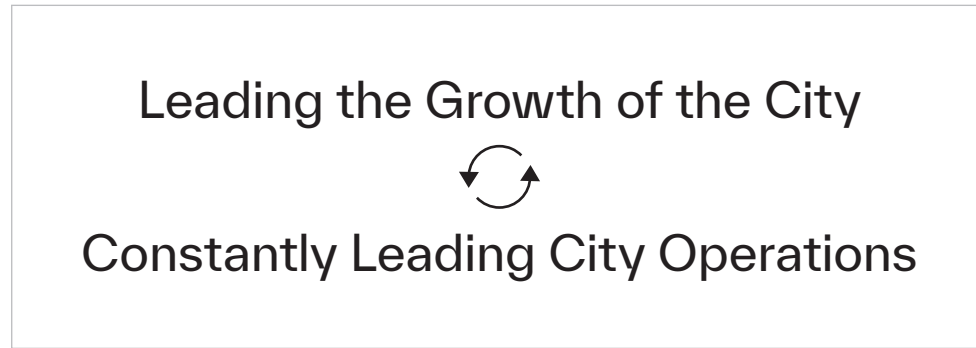
FOR AN EXCITING FUKUOKA

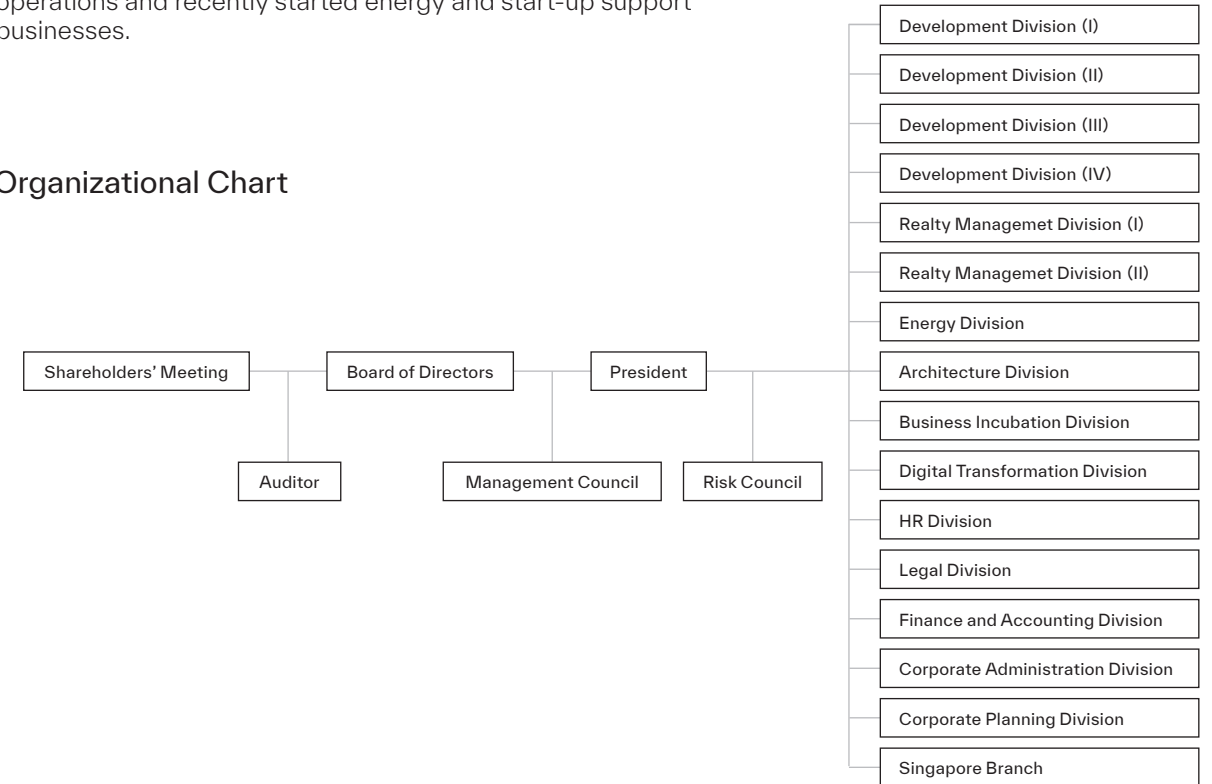

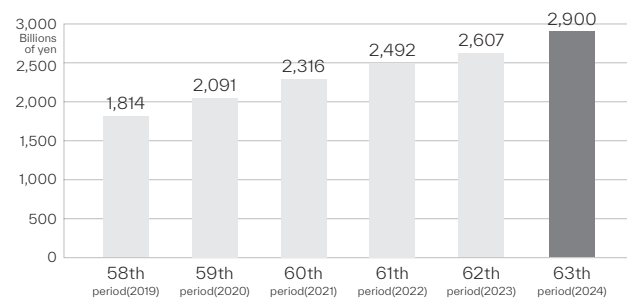

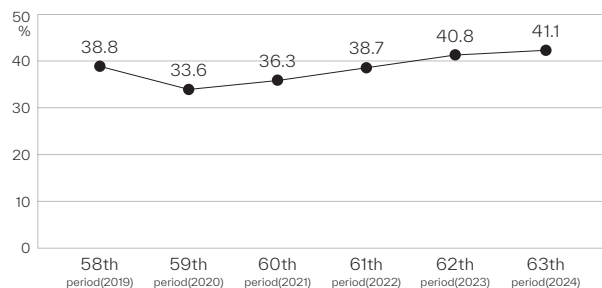
Profit Before Income Taxes
